1. Chair Phillips reminded everyone to submit all reimbursements by June 6th because the fiscal year ends June 30, 2025.
2. Chair Phillips invited everyone to attend the BOS meeting to accept the Pride Resolution on June 3, 2025 at 1:30pm.
3. Chair Phillips invited Sonoma County Pride on May 31, 2025 from 9am-4pm. Commissioner Thayer volunteered.
4. Tabling at RioFest on Saturday, June 21, 2025 from 12-6pm. Commissioner Hirsch, Chair Phillips and Commissioner Cruz Reyes volunteered to help.

VI. Ad Hoc Committee and Project Committee Updates

1. Sonoma County Human Rights Visibility Project 2.0 selected Commissioner Sohn as Chair. They are conversing on how to present the community and how the reporting will look like. They are researching and comparing this project to other counties.
2. Housing and Homelessness had concerns with Congress passing legislative that will hurt the Homeless population. Chair Phillips attended the Unhoused & Unheard Event that the Commission on the Status of Women hosted and were able to network with organizations in Sonoma County to better help the community.
3. Disability Justice are in contact with a mass block in Mendocino and with one in Oakland about distribution. This ad hoc will look at restructuring for the next fiscal year. Commissioner Sapper has volunteer to help.
4. Racial Equity and Social Justice Framework has done research to create an informational document. They might need more support to create the document but will try to present something for the commission to review. They will have unused funds.
5. Adult Prom created a flyer for the Pink Pony Prom on June 22 at 6pm. The ad hoc is looking for performers, drag queens, and seeking for decorations. They will have food trucks there. They were able to secure them by paying the \$100-\$200 so the first few people will get free food. Sonoma County Pride will be paying for the food. Space capacity is for 291 so they are hoping to have that many people show up.
6. Youth Commission on Human Rights attended a round table with Congressman Huffman at Santa Rosa Junior College and talked about homophobia that is going around at their high schools, the transphobia and the stigma. The Youth Commissioners had their last meeting and were given stoles. They are planning a trip to Alcatraz as an end of the year fieldtrip. Recruitment started for next cohort, and they have 23 applicants. 50% of the applicants are from Maria Carrillo High School.

Commissioners who got nominated provided acceptance speeches. Elections will take place next commission regular meeting. No action was taken.

2. Hot Topics

- a. Commissioner Thayer led the discussion about President Trump's executive order strengthening and unleashing America's law enforcement to pursue criminals and protect innocent civilians. There are two parts to this order: to deploy the military at home and to protect all police officers and police departments from any legal liability. The Commission brought up more concerns such as opening the door to privatizing police enforcement, the criminalization of DPI and increase violence. Commissioner Sapper, Commissioner Hirsch, Chair Phillips, Vice- Chair Warwick volunteered to draft a statement and Commissioner Benson volunteered to research for the statement. No action was taken.
- b. Chair Phillips led the discussion regarding Governor Newsom's push to ban homeless encampments. In Sonoma County, you can see people's belongings on the streets because people are getting arrested for being on the streets. Sonoma County Jail is getting overcrowded. The topic will be brought back during the strategic planning meeting.

3. Re-allocate Budget

- a. Chair Phillips led the budget discussion. The Youth Commission will have about \$1,000-\$1,200 of unused funds. Racial Equity and Social Justice Framework has \$2,463 of unused funds. Roughly \$3,400 of unused funds. Discussion on having all \$3,400 get allocated to the Adult Prom to pay for security, DJ, decorations, and food. Another discussion was to donate unused funds to a non-profit such as SOS, The Living Room, Act of Kindness, Need a Hand of Hope Sunshine Project, or Arlene Francis Center to help continue CHR mission's. Motion to approve remaining funds of about \$3,400 get leveraged to support Adult Prom with any remaining funds expeditiously donated to a non-profit or Arlene Francis Center. Motioned approved.

This ad hoc will be hosting an event with Community leaders and Commissions from the state. Budget of \$2,500.
- Environmental Rights to advocate human right to a healthy environment, a healthy, clean, and safe environment in the community.
- Disability Ad Hoc to support people with disabilities with a \$500 budget.
- Community Care Commission Ad Hoc to create a town hall or event with Health Services Department to do outreach and community education to bring people together and give them motivators to show up and learn about how we can be taking better care of each other, especially in the absence of government support and CDC consistency support. Budget request \$750.
- Youth Commission Educational Ad Hoc to continue their work with the youth. Budget request \$7530.
- 1–2-month Project- Universal Declaration Human Rights on Incarcerated Persons to create a workshop for 1-2 session among the incarcerated people, friends, family.
- Visibility Project Phase 2 will be creating a monthly newsletter. The Budget is \$2300
- Leadership Matrix to identify the skill sets of each Commissioner, their circles of influence, and organizations represented. This will help learn where the caps are.

Motion to support the proposed ad hocs and projects with a total of \$19,980 with general funds expenses. Motion approved.

To Our Elected Leaders, Public Safety Officials, and Community Members:

We, the Sonoma County Commission on Human Rights, speak today with profound concern and an unwavering call to action.

Recent remarks by President Trump—characterizing domestic violence as a “lesser crime” or mere “little fights” within the home—do more than echo outdated societal norms. They actively undermine efforts to prevent and respond to a crime that continues to endanger countless lives every day.

These comments are particularly jarring when juxtaposed with the tragic and deeply personal case involving two of our own Sheriff’s Office staff—Deputy Jeremy Lyle and Detention Specialist Mari Bonnici—whose relationship ended in a murder–suicide in August 2025. Mari was not only a mother and a colleague; she was a dedicated public servant whose life was stolen in an act of violence perpetrated by someone sworn to uphold the law. This tragedy—and others like it—remind us that domestic violence is never “lesser.” It is an urgent violation of personal dignity and public trust.

The harm wrought by dismissive rhetoric is compounded when paired with policy actions that strip away support and protection from survivors. Under the same administration, vital funding for domestic violence shelters and services has been slashed or stalled; qualifying abusers may be allowed a pathway to regain access to firearms; and human rights safeguards—such as those protecting immigrant survivors—have been weakened.

Domestic violence is a universal violation of human rights, demanding our unequivocal condemnation and our most faithful protection—especially when the perpetrators wear uniforms or carry authority.

We call upon all community leaders, elected officials, and peacekeepers to elevate the following commitments:

1. Stand Firm on the Truth
 - Reaffirm publicly and forcefully that domestic violence is a severe violation of human and civil rights—never a private matter to be minimized.
2. Ensure Transparent Accountability
 - Mandate impartial, external investigations for all domestic violence allegations involving public safety personnel. Transparency and fairness are non-negotiable.
3. Guarantee Support and Safety for Survivors

- Facilitate trauma-informed reporting channels so survivors—especially within public institutions—can seek help without fear of retaliation or career harm.

4. Protect Against Weapons Access for Abusers

- Enforce strict controls ensuring that individuals with histories of violence, especially domestic violence, cannot lawfully obtain firearms.

5. Safeguard Essential Services and Funding

- Prioritize and protect investments in shelters, counseling, legal advocacy, and immigrant-sensitive protections. Our community's well-being depends on them.

6. Model Courage, Not Complacency

- Leaders must embody the principle that “peace is not merely the absence of violence, but the presence of justice.” Let no statement or policy send the message that violence within the home is an acceptable casualty of politics or convenience.

Our collective humanity demands more than apathy. It demands action. Gossip and minimization have no place in addressing the systematic violence suffered by survivors—whose pain is real, whose fear is valid, and whose loss we must not dismiss.

To the memory of Mari Bonnici, to every survivor silenced within our own corridors, to all families yearning for protection and justice—we owe you more than apology. We owe you change.

Leadership begins not with proclamations—but with accountability, empathy, and enduring action.

WHEREAS, the Universal Declaration of Human Rights (UDHR) was adopted by the United Nations General Assembly on December 10, 1948, marking the first global articulation of the inalienable rights to which all human beings are inherently entitled; and

WHEREAS, the UDHR stands as a foundational document affirming that “all human beings are born free and equal in dignity and rights,” and continues to inspire international human rights treaties, laws, and movements around the world; and

WHEREAS, the Sonoma County Commission on Human Rights recognizes that these universal principles are not abstract ideals but guiding commitments for local governance, policy, and community life; and

WHEREAS, Sonoma County remains steadfast in its dedication to fostering a community that upholds human dignity, advances equity, and combats discrimination in all forms, including racism, sexism, ageism, ableism, xenophobia, and homophobia; and

WHEREAS, the Sonoma County Commission on Human Rights, through its initiatives, advocacy, and community partnerships, works to protect the rights of all residents and ensure that inclusion, safety, and justice remain priorities in civic and social life; and

WHEREAS, International Human Rights Day provides an annual opportunity to reflect on global progress, renew local commitments, and amplify education around human rights, especially for youth, marginalized populations, and communities historically excluded from full participation in public life; and

WHEREAS, the 2025 theme of Human Rights Day—“Dignity, Freedom, and Justice for All”—underscores the continued need for collective action to protect human rights in Sonoma County and beyond;

NOW, THEREFORE, BE IT RESOLVED, that the Sonoma County Board of Supervisors hereby recognizes December 10, 2025, as *International Human Rights Day* in Sonoma County, encourages residents to observe this day through acts of learning, compassion, and advocacy, and reaffirms its support for the mission of the Sonoma County Commission on Human Rights to protect, promote, and advance the rights and dignity of all people.
