## **Drug Medi-Cal Provider Directory October 2025**

As a Sonoma County Medi-Cal beneficiary, if you think you or a family member needs mental health services, call the Access Line at (707) 565-6900 or (800) 870-8786 (toll-free), or if you are hearing/speech impaired, call the California Relay Services (CRS) at 711 (TTY/TDD). The Access Team will perform a screening and referral to an appropriate Plan provider, who will perform an assessment to determine medical necessity.

Note that all of the below Providers can accommodate persons with physical disabilities and serve Sonoma County Medi-Cal beneficiaries.
