#### 2. Approval of June agenda and May minutes (Action item)

- Kathleen motions to approve the agenda and the minutes, Chessy seconds.
- No abstentions or objections. Motion passes.

#### 3. Coordinated Entry quarterly performance evaluation

Thai introduces Manny Galvin to present the quarterly performance evaluation. The report covers inflow, outflow, referral acceptance rates, program referral data and race equity analysis.

Key Highlights from the report

- Acceptance rate has increased from 46% Q3 2024 to 56% as Q3 2025.
- Families especially increased from a 40% acceptance rate in Q3 2024 to 58% in Q3 2025.
- Rejections due to 'Unknown/Disappeared' have decreased again- from 64 total for the FY in Q3 2024 to 29 total for the FY in Q3 2025.

#### Questions/comments from the committee

- Emily asked about the time form assessment to referral. What trends do we see with that data point?
  - Manny stated that it varies from reporting period to others. He noted that outliers affect this metric greatly.

#### Agenda Item Overview

HUD requires communities to perform a self-assessment of their Coordinated Entry System (CES) annually. The self-assessment covers all aspects of CES, including: planning, access, assessment, prioritization, referral, data management and evaluation. Each section of the self-assessment outlines required, recommended, and optional components and asks communities if they meet these components.

Lead agency staff has completed the self-assessment and will present the results to this committee. Due to the length of the self-assessment, staff will not go over each question but will present on which aspects of the self-assessment have and haven't been met. Staff will provide additional information about which components have not been met and why. A copy of the entire self-assessment can be found here: https://share.sonoma-county.org/link/-APOP3-Clrc/

In June, this committee heard the quarterly performance evaluation which presented data on CES outcomes. This self-assessment is the second part of a two-part assessment of the CE system in Sonoma County. In the August Homeless Coalition meeting, the lead agency and HomeFirst will present both the self-assessment and a presentation of performance data.
